

- D. Bill #3694 AN ORDINANCE PROHIBITING PARKING AND AUTHORIZING THE INSTALLATION OF “NO PARKING” SIGNS LIMITING PARKING ON THE EAST SIDE OF RED ROCK MEADOWS, INCLUDING THE CUL-DE-SAC WITHIN THE ESTATES AT ELLISVILLE MEADOWS SUBDIVISION.
- E. Res #09-16-20 A RESOLUTION REQUESTING THAT ST. LOUIS COUNTY DISTRIBUTE \$47 MILLION OF CARES ACT FUNDS ON A PER CAPITA BASIS TO THE MUNICIPALITIES WITHIN THE COUNTY TO BE USED FOR ELIGIBLE EXPENSES, AUTHORIZING THE MAYOR MIKE ROEMERMAN OF THE CITY OF ELLISVILLE, MISSOURI, TO ACCEPT CARES ACT FUNDING AND EXECUTE A MUNICIPALITY RELIEF PROGRAM FUNDING AGREEMENT, AND CONFIRMING AGREEMENT TO INDEMNIFY AND HOLD HARMLESS ST. LOUIS COUNTY FROM SUCH DISTRIBUTION.
